#### 1. PRODUCT DESCRIPTION:

#### **INSUL-TUBE® XT/LT**

Flexible, rubber-based, closed-cell foam insulation tube with a rubber-based adhesive covering strip and a self-adhesive closing system.

Density:  $(55 \pm 10) \text{ kg/m}^3$ .

Range of thickness: 6 to 50 mm.

INSUL-TUBE® XT/LT was tested glued on 1.0 mm steel sheet with same double-sided adhesive used for closing the tube system and by positioning the rubber-based adhesive covering strip at longitudinal median of specimen.

## **4. APPLICATION / LIMITATION:**

- 4.1 In application of FTP Code 2010 Annex 2 § 2.2, the product is expected to satisfy the requirement of smoke & toxicity without further testing.
- 4.2 In application of FTP Code 2010 Annex 2 § 2.3, the product is expected to satisfy the requirement of maximum gross calorific value (e.g. 45 MJ/m²) without further testing.
- 4.3 Approved for use as insulating material in cold service systems (mean of refrigeration systems and chilled water piping for air-conditioning systems).
- 4.4 The fitting aboard to be the same as used for the test.

#### **5. PRODUCTION SURVEY REQUIREMENTS:**
